Mr. Eskew explained that with the longer than normal lead time for materials, CRW has chosen to pre-order valves ahead of the start of the project. CRW will then later go out for bid for the installation contractor to complete the project. This project is more than what was budgeted for based on the facility plan because there has been a change in scope to have all valves replaces rather than some new and some rebuilt. Since this project is over what was budgeted, there has been some reshuffling of budget projects based on lead time and other external factors. Commissioner Garrison asked about rebuilding the valves over time if needed to extend the lifespan. Also, he asked if some of the new valves could be rebuilt and keep on hand in the event there is a need to replace a valve in the future. Commissioner Angier asked about the increase in cost over the author of the facility plan document estimates and the valves being ordered are higher quality and all being replaced as opposed to some rebuilt and others replaced.
