LOW INCOME WATER ASSISTANCE

LOW INCOME HOME WATER ASSISTANCE (LIHWA) PROGRAM

Clackamas River Water (CRW) and Clackamas County are working together in a new way with a program called <u>Low-Income Home Water Assistance</u> (LIHWA). This program is a new effort funded by the Federal government. It is currently only a one-time program.

About 79,428 households in Clackamas County may be eligible for this one-time program. LIHWA allows Clackamas County to directly pay CRW water bills for eligible households. **This support can be used for:**

Current Charges
 Past Due Amounts
 Reconnection Fees
 To be eliqible:

Household income must be at or below 60 percent of Oregon's median income based on size (see chart below).

To join the program, households must:

- **1)** Contact CRW Customer Service at CRW@crwater.com for a referral to Clackamas County.
- **2)** Clackamas County will contact customer to apply and provide supporting documents required to determine eligibility for the program.
- 3) Eligible CRW customers will be notified if funds are available.

The Down the River Clean Up is the largest and longest-running on-water cleanup event of its kind in Oregon, co-hosted by the Clackamas River Basin Council and We Love Clean Rivers.



Over 300 volunteers rally together in rafts, kayaks, and SCUBA gear, collecting an average of 1-3 tons each year, over half of which is recycled.


The event includes a trash sweep of a 20+ mile stretch of the Clackamas River from Estacada to the confluence with the Willamette River in Oregon City.

FISH ON THE RUN, **IRRIGATION DONE!**

Help keep water in the Clackamas River by participating in the "Fish On the Run, Irrigation Done!" annual late summer watering campaign. The Clackamas River Water Providers (CRWP) are asking water customers to help the river by reducing or shutting-off outdoor watering by the beginning of September when Fall Chinook and Coho

Salmon begin returning to the Clackamas River on the way to their spawning grounds.

In addition to providing drinking water to over 300,000 people, the river is home to migrating salmon and steelhead virtually year-



round. Most of the year there is plenty of water in the river, however, the river flows may become low in late summer and early fall when fish migration can start.

So, if you get your drinking water from the Clackamas River, here's your chance to be part of our annual "Fish On the Run, Irrigation Done!" campaign to help migrating fish.

Go to www.clackamasproviders.org and keep an eye out to discover what kind of changes you can make to your outdoor watering to ensure that you are using our drinking water in the most efficient ways possible. Take the pledge and receive a free yard sign (above) letting neighbors know what you are doing to keep water in the Clackamas River for fish.
