BACKGROUND	Commissioner Alexander resigned from the Clackamas River Water Board of Commissioners effective May 3, 2022. Commissioner Alexander occupied position #5 which expires June 30, 2025. The CRW Board will appoint a replacement that will serve until the next regular election in May 2023. Staff posted the vacancy on the CRW website and sent the vacancy notice to the Board distribution list and Budget Committee.

	Agenda Summary	
Background	Clackamas River Water ("CRW") and the North Clackamas County Water Commission ("NCCWC") are parties to a Water Supply Agreement dated March 8, 2001 (the "Water Supply Agreement"). The original Water Supply Agreement was set to expire on December 31, 2021 but was extended until no later than June 30, 2022 to allow additional time to develop an updated agreement.	
	Staff from CRW, CRW's legal counsel, and NCCWC staff have been working on developing a new long-term water supply agreement for consideration by the governing board of each entity.	
	A draft of a NCCWC/CRW Water Supply Agreement was shared with the CRW Board and discussed during the February 28, May 23 work sessions and May 12 Regular Board Meeting. The NCCWC Board has met and provided tentative approval of the agreement with final adoption to occur at their June board meeting. No changes have been made to the agreement as shared previously. A final version of the agreement is attached for the Board's consideration.

WATER SUPPLY AGREEMENT

This agreement is entered into this 1st day of July, 2022, between the Clackamas River Water District (hereinafter "CRW"), an ORS Chapter 264 Domestic Water Supply District, and the North Clackamas County Water Commission, (hereinafter "NCCWC"), a municipal organization formed under ORS 190 Intergovernmental Agreement, or collectively hereinafter referred to as the "Parties."

WHEREAS, the NCCWC currently purchases wholesale drinking water from CRW under an existing agreement dated March 8, 2001; and

WHEREAS, the existing water supply agreement is set to terminate June 30, 2022; and

WHEREAS, the NCCWC desires to renew a long-term supply agreement with CRW wherein allowing for greater flexibility and adaptability in meeting present and future demands, as well as emergency supply; and

WHEREAS, the NCCWC intends to expand its future purchases of wholesale water from CRW based on availability and the strategic interests of both Parties.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. Contract Period
 - A. This Agreement shall remain in effect until December 1, 2042, commencing with the execution of this Agreement, unless so approved otherwise by mutual written consent of the Parties.
 - B. The NCCWC agrees to notify CRW in writing of its desire to extend the term of this Agreement, but not later than two (2) years prior to the termination of this Agreement.
- 2. Available Capacity
 - A. CRW intends to provide up to 10 million gallons per day (mgd) of available treated water capacity to the NCCWC. In no event shall CRW be required to deliver water beyond that which is technically feasible through existing infrastructure, or which otherwise would create hardship to CRW.
 - B. The Parties shall mutually determine desired points of delivery and related transmission (flow rate) capacities for both regular and emergency service. The Parties may amend these points of delivery and capacities through mutual agreement among the Parties' General Managers or through the approved Planning Document, set forth under Section 3.B below.
 - C. In no event shall either Party be required to construct added pumping or transmission capacity to meet (or create) said desired points of delivery or flow rate capacities, unless so mutually approved in writing by both Parties. Any future construction of jointly owned assets shall be arranged under separate agreement among the Parties.

- 3. Use of Available Capacity
 - A. The NCCWC will purchase a minimum of 125 million cubic feet of water each year. The annual period for such purchase shall begin every year on July 1 and extend to the following date of June 30.
 - B. The Parties agree to make use of the available capacity defined under Section 2 above under a cooperative Planning Document. This Planning Document shall be based on a five (5) year forecast of demand and ten (10) year forecast of capital improvements. The Planning Document shall, among other items, identify:
 - i. Approved points of deliveries and peak flow capacities
 - ii. Peak and annual day demands and points of delivery
 - iii. Peak seasonal period (30 day) demand and points of delivery
 - iv. Updated schedule of mutually approved capital improvements

The demands created under this forecast, however, are not a strict obligation to purchase or deliver said amounts by either Party, other than the minimum amount stated in Section 3.A. The actual available capacity at any given time may be subject to existing limits on labor resources, infrastructure limits, or other factors outside the direct control of either Party.

Until the Parties mutually agree on a Planning Document as described in this Section 3.B, CRW will continue to supply water to NCCWC at existing points of delivery in amounts and at times, including peaking, consistently with the Parties' course of dealing in the twelve months preceding commencement of this Agreement.

The Planning Document and any amendments thereto must be approved in writing by the Parties' respective general managers; provided, however, that in the event the approval of any part of the Planning Document by a Party's governing body is required by law or by a Party's governance documents, a resolution of the Party's governing body will be required to provide that Party's approval.

- C. All use of available capacity shall be properly metered at each approved point of delivery through equipment supplied by the NCCWC, including (but not limited to): meter, valve(s), required backflow assembly and any other equipment so mutually approved by the Parties. The NCCWC shall, in turn, have each meter periodically tested and calibrated by a qualified, independent party for flow accuracy. The NCCWC shall also have each backflow assembly tested annually by an approved tester. The NCCWC shall provide copies of those test results to CRW upon completion.
- D. CRW shall in turn maintain all pipes, pumps, valves and other devices to allow for deliveries from its plant and reservoirs to meet the agreed flow capacities at each of the approved points of delivery.

4. Rates and Charges

- A. The methodology used to establish the Wholesale Water Rate under this agreement shall generally follow and be consistent with the standards of practice prescribed under the M1 Manual of the American Water Works Association (AWWA), except as otherwise mutually agreed by the Parties.
- B. Rates shall include, but not be limited to, payments for reasonable operation and maintenance expense, depreciation, administrative and general expenses, in-lieu taxes and other costs associated with CRW's financing and operation of its system. The Parties agree that, at a minimum, the rates paid by the NCCWC and all other consideration paid by the NCCWC pursuant to other agreements related to this Agreement will fully cover CRW's cost of providing water to the NCCWC.
- C. Rates may be adjusted each year on July 1 based on the change in the All Urban Consumers Consumer Price Index (CPI-U) West Class B/C or based on an update of the cost of service model prescribed in 4.A above, except as otherwise mutually agreed by the Parties.
- 5. Billing and Payment
 - A. Meters shall be read periodically by representatives of NCCWC at times fixed by mutual agreement of the Parties. CRW may elect to confirm such readings at any time.
 - B. CRW shall compute and render bills and statements to the NCCWC by the 5th day of each month. CRW shall invoice the NCCWC each month for water usage in the preceding month. NCCWC will in turn make payment on or before the 25th day of the month. A late fee of 1.5 percent per month may be assessed for any unpaid balance.
 - C. If the meters at any time fail to accurately measure the water passage through said meters and it is impracticable to determine actual average daily consumption with reasonable certainty, the charge for water used during the time said meters are out of order shall be based upon the average daily consumption as shown by said meters when in proper operating condition during a comparable period of service.
- 6. Water Exchange
 - A. CRW may on occasion request water be delivered by the NCCWC to various locations to meet operational or emergency supply needs. Such deliveries may be deducted, by equivalent volume, from the metered deliveries to the NCCWC. Such "water exchange," however, shall not affect the amount of water credited towards the annual minimum purchase required by the NCCWC.
 - B. However, no party shall be required to exchange water if it would not be technically feasible, require additional infrastructure not approved by separate agreement, or create hardship to the party being requested to do so.
- 7. [INTENTIONALLY LEFT BLANK]

- 8. Emergency Operations and Curtailment
 - A. In the event of an emergency (e.g. power outage, loss of infrastructure, etc.), the Parties agree to work in cooperation to best meet the demands of each Party and may temporarily suspend the terms of this Agreement to meet the operational needs of each Party and those of any third-party requesting assistance, provided the combined needs of each Party is not compromised through such third-party assistance. The Parties further agree that during the emergency each Party shall attempt to record any exchange of water or related service and work to resolve mutual consideration or compensation as prescribed in 6 above, absent the actual exchange of money, unless so agreed by the Parties.
 - B. In the event of a curtailment or other shortage of water supply, CRW and NCCWC shall share the shortage proportionately so long as NCCWC concurrently adopts and enforces the same customer water use restrictions adopted by CRW in response to the shortage.

9. Notices

All notices related to this Agreement shall be sent to the respective General Manager of each agency and shall be delivered in the form of e-mail or pre-paid mail sent to the appropriate address(es) below:

10. Severability

In the event any provisions of this Agreement shall be held to be impossible, invalid or unenforceable, the remaining provisions shall be valid and binding upon the parties hereto. One or more waivers by either party of any provision, term, condition or covenant, shall not be construed by the other party as a waiver of subsequent breach of the same by the other party. Both parties have fully participated in negotiating and writing this Agreement; therefore, it shall not be construed against the party preparing it, but shall be construed as if both parties have prepared it.

11. Acts of God, Emergencies, etc.

Performance or delay in performance of the obligations stated in this Agreement shall be reasonably excused when performance or timely performance is impossible or impracticable because of the occurrence of unforeseeable events such as emergency, catastrophe, disaster, labor disputes, or acts of God.

12. Disputes and Attorney's Fees

A. If a dispute arises between the parties regarding breach of this Agreement or interpretation of any term of this Agreement, the parties shall first attempt to resolve the dispute by negotiation, followed by mediation (if negotiation fails to resolve the dispute), and pursuant to the following steps:

- (i) <u>Step One</u>: The general manager or other person designated by the governing bodies will negotiate on behalf of the entities they represent. The nature of the dispute shall be reduced to writing and shall be presented to each manager who shall then meet and attempt to resolve the issue. If the dispute is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.
- (ii) <u>Step Two:</u> If the dispute cannot be resolved within ten days under Step One, the parties shall submit the matter to non-binding mediation. The parties shall attempt to agree on a mediator. If they cannot agree, the parties shall request the presiding judge of Clackamas County Circuit Court to appoint a mediator. The dispute shall then be heard by the mediator. The mediator's fees shall be shared equally by the parties. If the issue is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.
- (iii) <u>Step Three:</u> Disputes that are not resolved after exhausting Steps One and Two or within ninety (90) days, whichever comes earlier, shall be submitted to mutually agreeable arbitration or be resolved by proceedings in Clackamas County Circuit Court. If arbitration, suit or action is commenced, each party shall pay its own legal fees.
- 13. Full Agreement

This document is the entire, final and complete agreement of the parties pertaining to CRW's provision of surplus water to the NCCWC and supersedes and replaces all prior or existing written and oral agreements between the Parties or their representatives.

By signing this Agreement, the Parties agree to be bound by its terms and conditions for the entire period of its stated term.

BACKGROUND	CRW's wholesale water supply agreement is with North Clackamas County Water Commission (NCCWC). The agreement provides for annual adjustments to wholesale rates.	
	CRW along with FCS Group developed a rate model for wholesale water customers based on the M1 Manual of the American Water Works Association (AWWA). These rates beginning July 1, 2022, as follows:

Agenda Summary			
Background	In the expiring North Clackamas County Water Commission (NCCWC)/CRW water supply agreement is a provision that allows for the NCCWC or its members to provide water for CRW to serve CRW customers. OLWS is a member of the NCCWC along with Sunrise Water Authority and the City of Gladstone.		
	Since this provision allowing a NCCWC member to provide water applies only to the situation involving OLWS, it was thought that instead of including the provision as part of the new NCCWC/CRW Water Supply Agreement, a separate agreement between the affected parties (CRW and OLWS) would be developed. A draft of this agreement was shared as part of the May 23 CRW Work Session.		
	There are 368 CRW customers who are provided water in this manner under the agreement. These customers are in higher elevation portions of CRW's service area. OLWS and CRW staff have discussed that a boundary change in the future might be helpful in addressing this situation. The CRW and OLWS Boards would are being asked to approve a final agreement during their respective June meetings.

INTERGOVERNMENTAL WATER SUPPLY AGREEMENT FOR WATER SUPPLIED BY OLWS TO CRW CUSTOMERS

This agreement is entered into effective July 1, 2022, between the Clackamas River Water District ("CRW"), an ORS Chapter 264 Domestic Water Supply District, and the Oak Lodge Water Services District ("OLWS"), a consolidated Domestic Water and Sanitary District organized under ORS Chapters 198, 264, and 450 (collectively the "Parties").

WHEREAS, The North Clackamas County Water Commission ("NCCWC") currently purchases wholesale drinking water from CRW under an agreement dated March 8, 2001 (the "2001 NCCWC Agreement"), which also includes terms regarding the provision of water by NCCWC to CRW for use by CRW customers; and

WHEREAS, the 2001 NCCWC Agreement is set to terminate June 30, 2022, and will be replaced by a Water Supply Agreement between NCCWC and CRW (the "2022 NCCWC Agreement"); and

WHEREAS, OLWS is a member of the NCCWC and its water system is used to provide water to some CRW customers; and

WHEREAS, OLWS and CRW wish to enter into an agreement for OLWS's provision of water to CRW for use by CRW customers following termination of the 2001 NCCWC Agreement.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. <u>Water Supply</u>. OLWS agrees to provide water for domestic service to specific areas inside CRW's jurisdiction as mutually agreed by OLWS and CRW. Attachment A is a list of addresses of CRW customers that will be served with OLWS water on the effective date of this Agreement. CRW will compensate OLWS for water provided by OLWS to CRW using the formula set out in Section 4, below. Customers in these areas are served by CRW through CRW mains which in turn are connected to OLWS mains. For the purposes of this Agreement, these customers shall be referred to as "CRW customers served by OLWS."
- 2. <u>Connections</u>. Water main extensions connected to OLWS's system within CRW's jurisdiction shall be maintained by CRW.
- 3. <u>Meters</u>. Meters for CRW customers served by OLWS mains shall be installed, maintained and read by CRW. These meter readings will be the basis for compensation to OLWS as noted in Section 4. OLWS may check services for leakage or any other purpose.
- 4. <u>Compensation</u>. OLWS compensation for water delivered to CRW for use by CRW customers served by OLWS shall be determined as follows:
 - A. The total volume of water used by CRW customers served by OLWS, as determined by meter readings in CRW's normal billing process, will be calculated.

- B. The total volume of water determined in subsection (A) will be multiplied by a factor of 1.40 (the "Adjusted Consumption").
- C. CRW will pay OLWS an amount calculated by multiplying the Adjusted Consumption by the rate charged to NCCWC by CRW for water under the 2022 NCCWC Agreement, payable every other month.
- 5. <u>Termination</u>. This Agreement shall remain in effect until December 31, 2042, unless otherwise terminated by mutual agreement of the Parties.
- 6. <u>Notices</u>. All notices related to this Agreement shall be sent to the respective General Manager of each agency and shall be delivered in the form of e-mail or pre-paid mail sent to the appropriate address(es) below:

- 7. <u>Severability</u>. In the event any provisions of this Agreement shall be held to be impossible, invalid or unenforceable, the remaining provisions shall be valid and binding upon the parties hereto. One or more waivers by either party of any provision, term, condition or covenant, shall not be construed by the other party as a waiver of subsequent breach of the same by the other party. Both parties have fully participated in negotiating and writing this Agreement; therefore, it shall not be construed against the party preparing it, but shall be construed as if both parties have prepared it.
- 8. <u>Acts of God, Emergencies, etc</u>. Performance or delay in performance of the obligations stated in this Agreement shall be reasonably excused when performance or timely performance is impossible or impracticable because of the occurrence of unforeseeable events such as emergency, catastrophe, disaster, labor disputes, or acts of God.
- 9. <u>Disputes and Attorney's Fees</u>. If a dispute arises between the parties regarding breach of this Agreement or interpretation of any term of this Agreement, the parties shall first attempt to resolve the dispute by negotiation, followed by mediation (if negotiation fails to resolve the dispute), and pursuant to the following steps:
 - A. <u>Step One</u>: The general manager or other person designated by the governing bodies will negotiate on behalf of the entities they represent. The nature of the dispute shall be reduced to writing and shall be presented to each manager who shall then meet and attempt to resolve the issue. If the dispute is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.
 - B. <u>Step Two</u>: If the dispute cannot be resolved within ten days under Step One, the parties shall submit the matter to non-binding mediation. The parties shall attempt to agree on

a mediator. If they cannot agree, the parties shall request the presiding judge of Clackamas County Circuit Court to appoint a mediator. The dispute shall then be heard by the mediator. The mediator's fees shall be shared equally by the parties. If the issue is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.

- <u>Step Three</u>: Disputes that are not resolved after exhausting Steps One and Two or within ninety (90) days, whichever comes earlier, shall be submitted to mutually agreeable arbitration or be resolved by proceedings in Clackamas County Circuit Court. If arbitration, suit or action is commenced, each party shall pay its own legal fees.
- 10. <u>Full Agreement</u>. This document is the entire, final and complete agreement of the parties pertaining to OLWS's provision of water to CRW and supersedes and replaces all prior or existing written and oral agreements between the Parties or their representatives.
- 11. <u>Assignment</u>. This Agreement shall not be assignable by either Party without the written consent of the other Party. Notwithstanding the foregoing, the Parties acknowledge that the Clackamas County Board of Directors has adopted an order forming the Oak Lodge Water Services Authority and dissolving OLWS, which dissolution is anticipated to occur no later than December 31, 2022. It is the intent of the Parties, and the Parties hereby agree, that this agreement shall be assigned by OLWS to the Oak Lodge Water Services Authority, without the need for any further action by a Party, upon (a) the occurrence of both the official effective date of the Oak Lodge Water Services Authority and the official effective date of the dissolution of OLWS, and (b) action by the Oak Lodge Water Services Authority governing body to assume all obligations of OLWS under this Agreement.

By signing this Agreement, the Parties agree to be bound by its terms and conditions for the entire period of its stated term.

Background	The Clackamas Regional Water Supply Commission (CRWSC) was formed in December 2013 by intergovernmental agreement between Sunrise Water Authority (SWA) and CRW for the purpose of establishing a common legal entity under which operations, sharing of labor and resources, procurement and other activities could be done mutually amid a collective framework, taking advantage of increased utilization and economies of scale. The initial focus was to look at how the organizations could consolidate many of the functions associated with managing and operating a water system. The agreement also allowed for CRW to make available up to 10 million gallons a day of water under a separate water supply agreement within the CRWSC. Since its formation, CRW and SWA have remained the only members of the CRWSC. Currently, the primary activities of the CRWSC have centered around providing some staffing services and a mechanism for accessing water under a future water supply agreement. The CRWSC Board and respective member boards have discussed the value of continuing to operate under the CRWSC or if it would be more efficient to address the current activities of the CRWSC in separate agreements. A related development was the fact that the water supply agreement between CRW and the North Clackamas County Water Commission (NCCWC) was set to expire. The question of if you create a new water supply agreement with the NCCWC or within the CRWSC. The establishment of the CRW/NCCWC Water Supply Agreement would make a water supply agreement within the	

CRWSC unnecessary. The CRWSC Board reviewed the options and recommended that a water supply agreement be developed between CRW and the NCCWC and that steps be taken to dissolve the CRWSC. Given this direction, staff from the various organizations have been working on the development of the various agreements and actions necessary to allow for the dissolution of the CRWSC.

The CRWSC Agreement includes a provision (Section 12.3 of the CRWSC Agreement) that outlines the process for Dissolution of the CRWSC. A first step to dissolve the CRWSC would require a unanimous vote of its participating members which are CRW and SWA. Then a dissolution plan would be developed and finally dissolution will be complete once all debts and obligations are paid or a provision for payment is made.

Attached is the Agreement for the Dissolution of the CRWSC. As noted in Section 3, the CRWSC doesn't hold any physical assets. However, the supervisory control and data acquisition (SCADA) license used by both CRW and SWA is in the name of the CRWSC. The agreement points out that the SCADA license can be assigned to CRW. It is important to note that the agreement validates the intention of the parties by also referencing the water supply agreement between CRW and the NCCWC. Staffing services between SWA and CRW are being addressed in a separate agreement between SWA and CRW.

AGREEMENT AND PLAN TO DISSOLVE INTERGOVERNMENTAL AGENCY

This AGREEMENT AND PLAN TO DISSOLVE INTERGOVERNMENTAL AGENCY ("Agreement"), subject to the conditions stated herein, is entered into by and between Clackamas River Water, a domestic water supply district organized under ORS Chapter 264 and special district subject to ORS Chapter 198 ("CRW"), and Sunrise Water Authority, a water authority organized under ORS Chapter 450 and special district subject to ORS Chapter 198 ("SWA"), and collectively referred to as the "Parties."

RECITALS

WHEREAS, SWA owns and operates a municipal water supply system that includes, but is not limited to, the distribution of potable water to retail customers from various sources including wholesale purchases from CRW and other entities for such purpose; and

WHEREAS, CRW similarly owns and operates a municipal water supply system that includes, but is not limited to, the distribution of potable water to retail and wholesale customers from its own treatment plant; and

WHEREAS, pursuant to ORS Chapter 190, CRW and SWA entered into a Cooperative Intergovernmental Agreement, effective November 20, 2013 ("IGA"); and

WHEREAS, the IGA created the Clackamas Regional Water Supply Commission (the "Commission"); and

WHEREAS, the Commission has no debt, employees, or obligations or liabilities under any contract with any third party or otherwise; and

WHEREAS, the Parties desire to terminate the IGA and to dissolve the Commission and distribute any assets pursuant to Section 12.3 of the IGA.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties agree as follows:

- 1. **Dissolution of the Commission.** Pursuant to Section 12.3 of the IGA, the Commission is dissolved effective June 30, 2022 ("Effective Date"). Except to the extent necessary to dissolve the Commission, the Parties will not conduct any business or incur any obligations on behalf of the Commission as of the Effective Date.
- 2. Termination of the IGA. The IGA is terminated as of the Effective Date.
- 3. **Distribution of Assets.** The Commission holds no assets in its own name other than AVEVA HMI SCADA software, AVEVA Historian and Historian Client software, and related licenses (collectively, the "SCADA Licenses"). The Commission will assign the SCADA Licenses and all related support contracts to CRW, subject to CRW's right to refuse assignment and assumption of any such licenses or contracts.

- 4. Execution of Water Supply Agreement. No later than June 30, 2022, CRW will execute a water supply agreement, substantially in the form of Exhibit B, with the North Clackamas County Water Commission. The Parties will use commercially reasonable efforts to mutually determine a final form of agreement and will each coordinate with the North Clackamas County Water Commission for that purpose.
- 5. Assumption of Outstanding Debt or Other Liabilities. The Parties have conducted a diligent review of the Commission's accounts and agree that the Commission has no outstanding indebtedness or liabilities. Accordingly, neither Party assumes any indebtedness or liabilities of the Commission.
- 6. **Release.** The Parties release and discharge each other, each of their respective assigns and successors and each of their directors, officers, employees, and agents from all claims, liabilities, obligations, costs, and expenses arising out of or in connection with (a) the operation of the Commission and (b) the breach of any representation, warranty, or covenant in the IGA. All Commission assets distributed to the Parties pursuant to this Agreement are transferred as-is, with all faults, and without any representation or warranty by the transferring Party.
- 7. Further Cooperation. The Parties shall take all necessary and reasonable steps required to give effect to this Agreement, including, but not limited to, executing and documents and providing any notices to third parties. The Parties shall each be responsible for their own costs required to implement this Agreement and to wind up the Commission.
- 8. **Counterparts.** This Agreement may be executed in multiple counterparts, each of which are deemed an original, but all of which together constitute one and the same instrument. This Agreement may be executed by electronic signature.

EXHIBIT A

WATER SUPPLY AGREEMENT

This agreement is entered into this 1st day of July, 2022, between the Clackamas River Water District (hereinafter "CRW"), an ORS Chapter 264 Domestic Water Supply District, and the North Clackamas County Water Commission, (hereinafter "NCCWC"), a municipal organization formed under ORS 190 Intergovernmental Agreement, or collectively hereinafter referred to as the "Parties."

WHEREAS, the NCCWC currently purchases wholesale drinking water from CRW under an existing agreement dated March 8, 2001; and

WHEREAS, the existing water supply agreement is set to terminate June 30, 2022; and

WHEREAS, the NCCWC desires to renew a long-term supply agreement with CRW wherein allowing for greater flexibility and adaptability in meeting present and future demands, as well as emergency supply; and

WHEREAS, the NCCWC intends to expand its future purchases of wholesale water from CRW based on availability and the strategic interests of both Parties.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. Contract Period
 - A. This Agreement shall remain in effect until December 1, 2042, commencing with the execution of this Agreement, unless so approved otherwise by mutual written consent of the Parties.
 - B. The NCCWC agrees to notify CRW in writing of its desire to extend the term of this Agreement, but not later than two (2) years prior to the termination of this Agreement.
- 2. Available Capacity
 - A. CRW intends to provide up to 10 million gallons per day (mgd) of available treated water capacity to the NCCWC. In no event shall CRW be required to deliver water beyond that which is technically feasible through existing infrastructure, or which otherwise would create hardship to CRW.
 - B. The Parties shall mutually determine desired points of delivery and related transmission (flow rate) capacities for both regular and emergency service. The Parties may amend these points of delivery and capacities through mutual agreement among the Parties' General Managers or through the approved Planning Document, set forth under Section 3.B below.
 - C. In no event shall either Party be required to construct added pumping or transmission capacity to meet (or create) said desired points of delivery or flow rate capacities, unless so mutually approved in writing by both Parties. Any future construction of jointly owned assets shall be arranged under separate agreement among the Parties.

- 3. Use of Available Capacity
 - A. The NCCWC will purchase a minimum of 125 million cubic feet of water each year. The annual period for such purchase shall begin every year on July 1 and extend to the following date of June 30.
 - B. The Parties agree to make use of the available capacity defined under Section 2 above under a cooperative Planning Document. This Planning Document shall be based on a five (5) year forecast of demand and ten (10) year forecast of capital improvements. The Planning Document shall, among other items, identify:
 - i. Approved points of deliveries and peak flow capacities
 - ii. Peak and annual day demands and points of delivery
 - iii. Peak seasonal period (30 day) demand and points of delivery
 - iv. Updated schedule of mutually approved capital improvements

The demands created under this forecast, however, are not a strict obligation to purchase or deliver said amounts by either Party, other than the minimum amount stated in Section 3.A. The actual available capacity at any given time may be subject to existing limits on labor resources, infrastructure limits, or other factors outside the direct control of either Party.

Until the Parties mutually agree on a Planning Document as described in this Section 3.B, CRW will continue to supply water to NCCWC at existing points of delivery in amounts and at times, including peaking, consistently with the Parties' course of dealing in the twelve months preceding commencement of this Agreement.

The Planning Document and any amendments thereto must be approved in writing by the Parties' respective general managers; provided, however, that in the event the approval of any part of the Planning Document by a Party's governing body is required by law or by a Party's governance documents, a resolution of the Party's governing body will be required to provide that Party's approval.

- C. All use of available capacity shall be properly metered at each approved point of delivery through equipment supplied by the NCCWC, including (but not limited to): meter, valve(s), required backflow assembly and any other equipment so mutually approved by the Parties. The NCCWC shall, in turn, have each meter periodically tested and calibrated by a qualified, independent party for flow accuracy. The NCCWC shall also have each backflow assembly tested annually by an approved tester. The NCCWC shall provide copies of those test results to CRW upon completion.
- D. CRW shall in turn maintain all pipes, pumps, valves and other devices to allow for deliveries from its plant and reservoirs to meet the agreed flow capacities at each of the approved points of delivery.

4. Rates and Charges

- A. The methodology used to establish the Wholesale Water Rate under this agreement shall generally follow and be consistent with the standards of practice prescribed under the M1 Manual of the American Water Works Association (AWWA), except as otherwise mutually agreed by the Parties.
- B. Rates shall include, but not be limited to, payments for reasonable operation and maintenance expense, depreciation, administrative and general expenses, in-lieu taxes and other costs associated with CRW's financing and operation of its system. The Parties agree that, at a minimum, the rates paid by the NCCWC and all other consideration paid by the NCCWC pursuant to other agreements related to this Agreement will fully cover CRW's cost of providing water to the NCCWC.
- C. Rates may be adjusted each year on July 1 based on the change in the All Urban Consumers Consumer Price Index (CPI-U) West Class B/C or based on an update of the cost of service model prescribed in 4.A above, except as otherwise mutually agreed by the Parties.
- 5. Billing and Payment
 - A. Meters shall be read periodically by representatives of NCCWC at times fixed by mutual agreement of the Parties. CRW may elect to confirm such readings at any time.
 - B. CRW shall compute and render bills and statements to the NCCWC by the 5th day of each month. CRW shall invoice the NCCWC each month for water usage in the preceding month. NCCWC will in turn make payment on or before the 25th day of the month. A late fee of 1.5 percent per month may be assessed for any unpaid balance.
 - C. If the meters at any time fail to accurately measure the water passage through said meters and it is impracticable to determine actual average daily consumption with reasonable certainty, the charge for water used during the time said meters are out of order shall be based upon the average daily consumption as shown by said meters when in proper operating condition during a comparable period of service.

6. Water Exchange

- A. CRW may on occasion request water be delivered by the NCCWC to various locations to meet operational or emergency supply needs. Such deliveries may be deducted, by equivalent volume, from the metered deliveries to the NCCWC. Such "water exchange," however, shall not affect the amount of water credited towards the annual minimum purchase required by the NCCWC.
- B. However, no party shall be required to exchange water if it would not be technically feasible, require additional infrastructure not approved by separate agreement, or create hardship to the party being requested to do so.

7. [INTENTIONALLY LEFT BLANK]

- 8. Emergency Operations and Curtailment
 - A. In the event of an emergency (e.g. power outage, loss of infrastructure, etc.), the Parties agree to work in cooperation to best meet the demands of each Party and may temporarily suspend the terms of this Agreement to meet the operational needs of each Party and those of any third-party requesting assistance, provided the combined needs of each Party is not compromised through such third-party assistance. The Parties further agree that during the emergency each Party shall attempt to record any exchange of water or related service and work to resolve mutual consideration or compensation as prescribed in 6 above, absent the actual exchange of money, unless so agreed by the Parties.
 - B. In the event of a curtailment or other shortage of water supply, CRW and NCCWC shall share the shortage proportionately so long as NCCWC concurrently adopts and enforces the same customer water use restrictions adopted by CRW in response to the shortage.

9. Notices

All notices related to this Agreement shall be sent to the respective General Manager of each agency and shall be delivered in the form of e-mail or pre-paid mail sent to the appropriate address(es) below:

10. Severability

In the event any provisions of this Agreement shall be held to be impossible, invalid or unenforceable, the remaining provisions shall be valid and binding upon the parties hereto. One or more waivers by either party of any provision, term, condition or covenant, shall not be construed by the other party as a waiver of subsequent breach of the same by the other party. Both parties have fully participated in negotiating and writing this Agreement; therefore, it shall not be construed against the party preparing it, but shall be construed as if both parties have prepared it.

11. Acts of God, Emergencies, etc.

Performance or delay in performance of the obligations stated in this Agreement shall be reasonably excused when performance or timely performance is impossible or impracticable because of the occurrence of unforeseeable events such as emergency, catastrophe, disaster, labor disputes, or acts of God.

12. Disputes and Attorney's Fees

A. If a dispute arises between the parties regarding breach of this Agreement or interpretation of any term of this Agreement, the parties shall first attempt to resolve the dispute by negotiation, followed by mediation (if negotiation fails to resolve the dispute), and pursuant to the following steps:

- (i) <u>Step One</u>: The general manager or other person designated by the governing bodies will negotiate on behalf of the entities they represent. The nature of the dispute shall be reduced to writing and shall be presented to each manager who shall then meet and attempt to resolve the issue. If the dispute is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.
- (ii) <u>Step Two:</u> If the dispute cannot be resolved within ten days under Step One, the parties shall submit the matter to non-binding mediation. The parties shall attempt to agree on a mediator. If they cannot agree, the parties shall request the presiding judge of Clackamas County Circuit Court to appoint a mediator. The dispute shall then be heard by the mediator. The mediator's fees shall be shared equally by the parties. If the issue is resolved at this step, there shall be a written determination of such resolution, signed by each party's manager and ratified by each governing body, which shall be binding upon the parties.
- (iii) <u>Step Three:</u> Disputes that are not resolved after exhausting Steps One and Two or within ninety (90) days, whichever comes earlier, shall be submitted to mutually agreeable arbitration or be resolved by proceedings in Clackamas County Circuit Court. If arbitration, suit or action is commenced, each party shall pay its own legal fees.
- 13. Full Agreement

This document is the entire, final and complete agreement of the parties pertaining to CRW's provision of surplus water to the NCCWC and supersedes and replaces all prior or existing written and oral agreements between the Parties or their representatives.

By signing this Agreement, the Parties agree to be bound by its terms and conditions for the entire period of its stated term.

INTERGOVERNMENTAL AGREEMENT FOR SERVICES

This INTERGOVERNMENTAL AGREEMENT FOR SERVICES ("Agreement"), subject to the conditions stated herein, is entered into by and between Clackamas River Water, a domestic water supply district organized under ORS Chapter 264 and special district subject to ORS Chapter 198 ("CRW"), and Sunrise Water Authority, a water authority organized under ORS Chapter 450 and special district subject to ORS Chapter 198 ("SWA"), and collectively referred to as the "Parties."

RECITALS

WHEREAS, SWA owns and operates a municipal water supply system that includes, but is not limited to, the distribution of potable water to retail customers from various sources; and

WHEREAS, CRW similarly owns and operates a municipal water supply system that includes, but is not limited to, the distribution of potable water to retail and wholesale customers; and

WHEREAS, pursuant to ORS Chapter 190, CRW and SWA entered into a Cooperative Intergovernmental Agreement, effective November 20, 2013 (the "CRWSC IGA"), creating the Clackamas Regional Water Supply Commission (the "CRWSC"); and

WHEREAS, CRW provided certain services to SWA through the CRWSC and pursuant to the CRWSC IGA; and

WHEREAS, the Parties terminated the CRWSC IGA and dissolved the CRWSC effective June 30, 2022, 2022; and

WHEREAS, SWA wishes to continue receiving certain services from CRW and CRW wishes to continue providing certain services to SWA on agreed-upon terms; and

WHEREAS, this Agreement is entered into pursuant to ORS 190.010, which confers authority on local governments to enter into agreements for the performance of any and all functions and activities that a party to the agreements, its officers or agencies have authority to perform.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties agree as follows.

AGREEMENT

1. **CRW Services to SWA.** CRW through its agents and employees, will perform such services as SWA may request from time to time, so long as CRW is able and willing to provide the services. Services may include, without limitation, payroll, information technology, procurement, and Supervisory Control and Data Acquisition ("SCADA") or other services as mutually agreed by the Parties. The scope of a services provided by CRW to SWA will be

set out in one or more memorandums of understanding ("MOU") executed by the respective general managers of CRW and SWA.

- 2. Consideration for Services. Unless otherwise agreed to in an MOU with respect to the services provided under that MOU, SWA will compensate CRW for services rendered on a time and materials basis. Compensation for the time of CRW employees will be based on an hourly rate determined by the full employment cost of the employee to CRW, including without limitation salary, payroll taxes, insurance, and other employee benefits, and an overhead rate as established in the CRW Fees and Charges document adopted by the CRW Board of Commissioners. Compensation for materials, equipment, and other out-of-pocket expenses of CRW will be based on the actual cost of goods, third-party services, or other items of value purchased to provide services to SWA. In the event CRW purchases or has purchased goods or services that will be shared with SWA, SWA will be responsible for its proportionate share of the expense for such goods or services.
- 3. **Term and Termination.** This Agreement is effective July 1, 2022. This Agreement and all MOUs issued pursuant to this Agreement will terminate on June 30, 2027, unless terminated earlier pursuant to this paragraph. Either of the Parties may terminate this Agreement or any MOU issued pursuant to this Agreement with sixty (60) days' written notice.
- 4. **Responsibilities of CRW.** Except for its obligation to indemnify SWA, CRW does not assume any responsibility under this agreement other than to render the services called for in good faith. CRW will not be deemed to be in violation of this Agreement if CRW is prevented from performing its obligations for any reason beyond its reasonable control.
- 5. Indemnification. (a) Subject to the limits of the Oregon Constitution and the Oregon Tort Claims Act or successor statute, SWA agrees to indemnify, save harmless and defend CRW, its officers, elected officials, agents and employees from and against all costs, losses, damages, claims or actions and all expenses incidental to the investigation and defense thereof (including legal and other professional fees) arising out of or based upon damages or injuries to person or property caused by the negligent or willful acts of SWA or its officers, elected officials, owners, employees, agents or its subcontractors or anyone over which SWA has a right to control.

(b) Subject to the limits of the Oregon Constitution and the Oregon Tort Claims Act or successor statute, CRW agrees to indemnify, save harmless and defend SWA, its officers, elected officials, agents and employees from and against all costs, losses, damages, claims or actions and all expenses incidental to the investigation and defense thereof (including legal and other professional fees) arising out of or based upon damages or injuries to persons or property caused by the negligent or willful acts of CRW or its officers, elected officials, owners, employees, agents, or its subcontractors or anyone over which CRW has a right to control.

6. **Independent Contractor**. CRW shall be deemed an independent contractor for purposes of this Agreement. No representative, agent, employee or contractor of one Party shall be deemed to be a representative, agent, employee or contractor of the other Party for any

purpose, except to the extent specifically provided herein. Nothing herein is intended, nor shall it be construed, to create between the Parties any relationship of principal and agent, partnership, joint venture or any similar relationship, and each Party hereby specifically disclaims any such relationship.

- 7. Third Party Beneficiary. Neither Party intends that this Agreement benefit, or create any right or cause of action in, or on behalf of, any person or entity other than the Parties.
- 8. No Assignment. No Party shall have the right to assign its interest in this Agreement (or any portion thereof) without the prior written consent of the other Party, which consent may be withheld for any reason.
- 9. **Counterparts.** This Agreement may be executed in multiple counterparts, each of which are deemed an original, but all of which together constitute one and the same instrument. This Agreement may be executed by electronic signature.

	At the end of each fiscal year, in preparation for the annual audit, staff has the opportunity to recognize those receivables that are "doubtful" and should be removed from the balance sheet.
	 The process for UB accounts with bad debts: Account is closed, send final bill. Based on the due date in the intent to collect letter, the account is turned over to the collection company including all pertinent information on the customer in the CRW files. If CRW receives additional information, it is forwarded to the collection company. CRW has used Professional Credit Services for collections on bad debt accounts since October 1, 2012. By law, CRW is not allowed to turn over or pursue bankruptcy accounts outside of the formal bankruptcy process. There is one (1) account in bankruptcy for bad debt write-off for FY 2021-22. Bad debts are divided into three types or groups: bankrupt, commercial/industrial, and residential.

Commercial are business accounts, while residential accounts are homeowner, renter or landlord accounts. CRW does not pursue collection on an old bill from a new owner, landlord or renter even if the water service was shut off for non-payment. The water usage follows the former owner or tenant.

This year, staff is recommending \$13,505.44 of write offs on 49 utility billing accounts. CRW customer accounting staff works diligently to pursue collection on outstanding utility accounts. All collectible accounts have been turned over to Professional Credit Services for collections.

The percent of bad debts for write off is just over 0.1% of total retail water sales of \$13,015,636 for the fiscal year ending June 2021.

For 2022 bad debt (accounts closed prior to or on 06/30/2021):

- Bankruptcy 1 account for \$ 96.76
- Commercial/industrial 2 accounts for \$ 221.73
- Residential 46 accounts for \$13,186.95

The 10-year average annual write off amount is \$11,693 (2012-2021). This year the write off is \$1,812 over the 10-year average.

The lowest annual write off was in 2014 for approximately \$7,097. The highest amount in the last 10 years was 2017, for approximately \$17,088. The second highest is FY2020, for approximately \$14,055 and third highest was 2021 for approximately \$13,505.

Collection on CRW utility billing accounts remains high through repeated notices requesting payment, direct phone calls, and tracking customers within district boundaries. Through May 26, 2022, we have collected from Professional Credit Services \$225 on prior bad debt write-off accounts. Professional Credit Services will continue to pursue collections on behalf of CRW even though accounts have been written off in the past.



BACKGROUND	In 2001, a waterline easement was granted to CRW by L&W LLC / LZN Excavating Inc, for construction of a 12-inch diameter ductile iron waterline across the property at 9550 SE Clackamas Road, TL 22E09DB 00802. The recorded easement allows CRW the ability to access and maintain its waterline and related features on the subject property. Recently, the current property owner (Peterson Machinery Company) has planned and begun to make improvements to the property. Some of these improvements will encroach upon the existing easement area- therefore Staff has met with the property owner to discuss options to these improvements to minimize easement encroachment and preserve CRW access to its facilities.
ANALYSIS	The existing easement states "Neither Grantor nor its successors in title will erect any structures or other improvements upon the property which is the subject of the easement, which will unreasonably interfere with Grantee's exercise of its easement and right of entry". Due to an oversight by the property owner, planned improvements were initiated without first consulting with CRW regarding protection of the easement area. Staff met with the property owner in late May on site to discuss proposed layout and options that would better protect CRW's access to its waterline. The owner has agreed to modify the improvements in order to allow required access for CRW, for any future waterline maintenance or repair

needs, which better meets the original easement language for improvements that do not unreasonably interfere with CRW's easement rights. Additionally, the owner agrees to hold CRW harmless for any future damage to their improvements resulting from CRW's waterline maintenance and/or repairs, as well as agreeing that no other improvements are permitted within the easement (both statements are supported by the original easement document). In a spirit of cooperation, CRW has crafted the easement amendment to help accommodate the property owner's improvements, while protecting CRW assets for the future. The easement amendment was drafted by legal counsel and meets legal requirements. STAFF Approve the amendment to the waterline easement at 9550 SE Clackamas RECOMMENDATION Road as written and authorize the General Manager to sign the final document.

PETERSON MACHINERY COMPANY ("Grantor") is the successor in interest to L & W L.C.C., LZN Excavating Inc., which granted to **CLACKAMAS RIVER WATER**, a domestic water supply district and municipal corporation ("Grantee"), a right of entry and easement (collectively, "Easement") pursuant to the Waterline Easement attached as EXHIBIT A. By their signatures below, Grantor and Grantee amend the Waterline Easement. The Easement, as amended, encumbers a parcel of land located in Clackamas County, Oregon, and legally described and depicted on <u>EXHIBIT B</u> ("Easement Area"), which <u>EXHIBIT B</u> is attached hereto and incorporated by reference into this Amendment to Waterline Easement.

Pursuant to ORS 93.030(2), the true and actual consideration for this Amendment to Waterline Easement is **\$0.00**.

- 3. No utilities shall cross the Easement Area or be secured to the Improvements in such a way that would further interfere with Grantee's ability to access its water main and related facilities.
- 4. During construction, Grantor shall provide investigative potholing of the 12" water main to ascertain location and/or depth. In no case shall construction of the Improvements encroach within two feet (vertically) of the water main.
- 5. Grantor shall restore the gate on the fence surrounding the upper section of the property adjacent to the eastern end of Alansa Court and western edge of the existing easement, and shall provide Grantee access to both the upper and lower (main) gate accessing the property, for access to the water main and related features.
- 6. Grantor shall hold Grantee harmless from the consequences of Grantor's construction of the Improvements within the Easement Area. 

Background	Agenda Summary This project was a 12-inch water main extension to serve two developments at the SE corner of the Clackamas Town Center (CTC), south of the TriMet parking structure. The water main was designed and constructed in a cooperative agreement between the two hotel developments and included 750± lineal feet of 12-inch water line; two new 4-inch water meters, and two new 6-inch fire services. CRW involvement with this project actually begin in late 2018 with
	hydraulic modeling and planning assistance. Plan review followed in November of 2019 with construction occurring in March through June of 2020. The developer focused their efforts on the site development with little attention to completing the waterline facilities until recently with building and site work construction continuing to this day.

A. Management Report

1. Communications:

Monthly Report – The monthly report will be provided to the Board separately and posted on the CRW Website.

2. Intergovernmental Relations:

<u>Regional Water Providers Consortium (RWPC) Board Meeting</u> – The RWPC Board met on June 1 to receive updates, elect officers, and review program reports. The RWPC is also celebrating its 25th Anniversary so staff provided an overview of the milestones and projects over the past 25 years. The RWPC Board members then had a brief break out session to begin to discuss what they would like the RWPC accomplish in the next 25 years.

The RWPC reelected Tualatin Councilor Bridget Brooks to serve as the Board Chair and elected Kevin Williams of Oak Lodge Water Services to be the Vice Chair for the coming year. Executive Committee members representing each County were also selected during the meeting. CRW Commissioner, Naomi Angier will represent water providers in Clackamas County. Jim Duggan of Tualatin Valley Water District and Tom Lewis of Rockwood Water PUD we reappointed as representatives for Washington and Multnomah Counties respectively.

<u>RWPC Tabletop Exercise</u> – A virtual tabletop exercise was held by the RWPC on June 2. The focus of the exercise was to look at curtailment communications and coordination between water providers. Given the various water sources in the Portland Metro Area, water providers might be impacted differently depending on their source of supply. The exercise created a greater awareness of the different approaches to curtailment. The event also focused on how curtailment messages and/or restrictions might be communicated both within the water provider community and externally to the public.

<u>Clackamas River Water Providers (CRWP)</u> — The CRWP June 1 meeting included a presentation from Portland General Electric (PGE) on summer operations. PGE is anticipating a more typical year of operations yet will still be dealing with addressing damage from the fires and putting some facilities back into service. They have begun the annual algal bloom monitoring which is coordinated with the CRW Water Quality Lab. It was also noted the later snowpack in the watershed was welcomed and it appears that it should be a good water year.

The CRWP members then continued to discuss the summer water supply. Given the positive water supply the group agreed to implement the "Fish on the Run Irrigation Done" as intended (i.e., mid-August). Current river flows appear to be within a typical range.

Much of the meeting was spent discussing the CRWP's approach to conservation and curtailment messaging within the Clackamas Basin. Given that the different water providers have different conservation and curtailment plans the members talked about how best to keep each other informed and coordinate on messaging. This was a valuable discussion give the RWPC tabletop exercise the next day. The CRWP is also looking at expanding the Conservation Rebate Program to add devices that can be used to detect leaks in a home.

The CRWP elected a chair and vice chair at the meeting. Wyatt Parno of South Fork Water Board will serve as the CRWP Chair and Bret Bienerth will serve as the CRWP Vice Chair. Both terms will start on July 1. CRW representative, Todd Heidgerken will conclude his service as the CRWP Chair.

3. CRW Water Management and Conservation Plan (WMCP):

Oregon Water Resources Department issued its "Final Order" approving the CRW WMCP. The content and process of a WMCP is governed by Oregon Administrative Rules (OAR). Approval of the WMCP is for 10 years and CRW will be required to submit a progress report in 5 years. Staff will include a presentation on the plan during the July CRW Board meeting.

4. Emergency Management Update:

Trainings continue for the Incident Management Team and Incident Support Team members. Incident Command System (ICS) 300 Classroom training dates have been scheduled for September 27, 28, 29. The goal is to be prepared for the October 20th exercise to test roles in activation and initial response to an Earthquake.

5. Security Update:

<u>Riverside Park Monitoring</u> - CRW is having a new presence at Riverside Park 5 days of the week to promote safety and appropriate use of the park facilities. Executive Security Services International (ESSI) is the vendor. Their shift is from approximately 1pm to 15 minutes after sunset. They are monitoring park conditions, ensuring patrons feel welcome, ensuring the park is closed at night and provides our Emergency Manager with details on events that occur.

<u>Security Review of Pump Stations and Reservoirs</u> - Partnership with West Yost Associates (Consultant) on security rankings for pump stations and reservoirs will be completed at the end of June. Anticipate first draft of recommendations on June 10th.

6. Safety Update:

The Safety Committee launched a new engagement campaign to highlight our mutual support for our coworkers to work safely, both physically and psychologically. Studies have shown that engaged employees are safer employees. Working as a collective, rather than as individuals, we can meet the challenges we face.



7. Board Officer Elections: Section 2.2 of the Board Policies outlines the process for selecting officers. The Board can conduct the officer elections during the June meeting if there is no change in the Board's membership. Given the resignation of Commissioner Alexander, there will be a change in the Board membership therefore the Board elections will be held at the beginning of the July 14 Board meeting.

8. Looking Ahead:

- There is no Board Work Session in June
- The agenda preparation meeting for the July Board meeting will be held on Thursday, June 30 at 12:30pm
- CRW Offices will be closed on Monday, June 20th to observe the Juneteenth Holiday.
- Heidgerken is out of the office on June 16 (Kirkpatrick is Acting in Capacity AIC), June 20-23 (Bjornstedt is AIC) and July 2-12 (Bjornstedt is AIC).
- The July Board meeting will be held on Thursday, July 14 at 6pm
