

As a condition of this water right permit, CRW developed a Water Management and Conservation Plan (WMCP) back in 2011 that fulfilled the requirements of Oregon Administrative Rules (OAR Chapter 690 Division 86). This current plan remains in effect until January 31, 2022. With the expiration of the current plan approaching, CRW initiated the development of an updated WMCP. To assist with this project, CRW selected GSI Water Solutions (GSI) to develop an updated WMCP to help CRW manage its water resources efficiently and meet the requirement of the Oregon Administrative Rules. CRW staff has been working with GSI to update the WMCP. Representatives from GSI will be providing the Board with: An overview of WMCPs • A walk through some of the major elements addressed in drafting the CRW WMCP An opportunity to answer any questions and receive feedback on the approach Review of next steps in the planning process.




Curtailment Plan

- Plan revised to focus on system function
- Triggers based on operational impacts of water shortage, i.e. reservoir levels relative to fire flow storage volumes requirements
- Flexibility to modify triggers and associated measures
- Distinction between curtailment and conservation



Curtailment Plan (continued.)



BACKGROUND	Clackamas River Water is a member of the Clackamas River Water Providers (CRWP). The CRWP members include the Cities of Estacada, Lake Oswego, Gladstone, Tigard and Oak Lodge Water Services, South Fork Water Board, Sunrise Water Authority and Clackamas River Water. As members of the CRWP, we support the activities of the CRWP through membership dues. The CRWP is an organization that coordinates source water protection programs in the Clackamas Basin. 

Background	 Most of CRW's revenue comes from water sales to residential and commercial customers. In FY 2021 retail water revenue was 97% of CRW's total General Fund Revenue. Retail water sales includes residential, multi-family, commercial and irrigation sales. Given recent questions from the Board, time has been set aside to provide an overview of CRW's: billing process; payment methods and associated costs; and impacts of COVID-19 to our customers and the District 			
	 Billing Process: CRW customers receive bills every two months. The exception to this is our only wholesale customer (Sunrise Water Authority/NCCWC) which is billed monthly. The District's billing is broken up into "cycles". This helps to distribute the workload and spread revenue over the 2-month period. Examples of billing cycles include: Cycle 1 and Cycle 2 are North of the Clackamas River, primarily residential accounts, and are billed on the even months and due the 15th of the odd months. Cycle 3 is South of the Clackamas River and includes all types of accounts and are billed on the even months and due the 15th of the odd months. Cycle 4 is commercial/industrial (large meter) North of the Clackamas River and is billed on the odd months and due the 15th of the even months. 			
	Revenue is seasonal with more earned in the summer months and less during the winter. This cyclical revenue is illustrated in the Monthly Reports provided to the Board monthly.			

A common question that we receive from customers is how the water bill is calculated. Residential customers are billed a base charge (fixed amount that is based on meter size) and block rates for water usage (amount of water used as measured by the water meter and expressed in 100 cubic feet (CCF)) One CCF equates to 748 gallons of water. Commercial and industrial accounts also have base rates and block rates calculated on a winter average basis for that specific customer. Block rates allow for the water rate to increase as more water is used.

Methods of Payment:

There have been significant changes in how utilities collect revenue. With more demand for online information and payment methods, customers have transitioned from the traditional cash/check method to the use of credit/debit cards or other online payment methods. The use of more card or electronic payment methods have shifted costs to merchant fees from lockbox or depository services, however the costs and timing involved with collecting cash/checks has greatly reduced staff time and shortened the time it takes to resolve a customer issue.

COVID Impacts:

With the onset of the pandemic and given the uncertainty on the District and its customers, CRW took a number of steps to provide greater flexibility for our customers. Examples of these steps included:

- Delaying implementation of the May 1, 2020, rate increase
- Suspending late fees
- Suspending shutoffs for non-payment

These actions did impact revenue. The other result is that some customers built up larger than normal unpaid balances. Staff has been working with these customers to get these accounts current while also phasing our processes back to the normal billing, notice and collection timelines.
